Report: 2015 US Coral Reef Task Force, October 24 to October 31, 2015 Fajardo, Puerto Rico.

The United States Coral Reef Task Force (USCRTF) was established in 1998 by Presidential Executive Order to lead U.S. efforts to preserve and protect coral reef ecosystems. The USCRTF includes leaders of twelve (12) Federal agencies, seven (7) U.S. States, Territories, Commonwealths and three (3) Freely Associated States. The USCRTF helps build partnerships, strategies, and support for on-the-ground action to conserve coral reefs. Every year they hold two meetings, one in Washington DC and the other one in one of their jurisdictions-states. This year Puerto Rico hosted the 34th USCRTF meeting in Fajardo, October 24 – 31, 2015 (Meeting Agenda can be found in Appendix A).

In partnership with the National Oceanic and Atmospheric Administration's (NOAA) Coral Reef Conservation Program, The Nature Conservancy (TNC) supported this year's USCRTF by coordinating and facilitating the following activities:

I. Community Sharing Session - October 28, 2015

TNC Staff supported this year's USCRTF by engaging high level US Federal and local government officials, stakeholders, communities, and partner jurisdictions in sharing lessons learned from Puerto Rico's coral reef conservation efforts. During the USCRTF, TNC hosted the USCRTF Community Sharing Session at the Governor's Beach House, *Finca el Convento*, which was attended by high level government officials, local NGOs and community members. During the event representatives from nine local NGOs presented their work and efforts in the conservation of coral reefs.

II. Contractor Position to support the USCRTF planning process

To support the PR Department of Environmental and Natural Resources (DNER) during the USCRTF planning process, TNC sponsored a contractor position (Ahava Events Puerto Rico) to join the USCRTF meeting planning committee, composed of representatives from agencies and jurisdictions that make the Task Force, such as NOAA (Sherry Simpson, Antares Ramos, Rob Ferguson and Carey Morishige), Department of Interior (Cheryll Fossani) and DRNA (Damaris Delgado and Tania Metz). The contractor was tasked with coordinating between agencies, organizations, and stakeholder groups and bringing local support and connections to the USCRTFM planning committee. During this planning process, TNC's contractor was responsible of the following tasks:

- Frequent in-person meetings and daily communication with local representatives (Tania Metz and Damaris Delgado) to review documents, letters and proposals regarding sponsorship and venue options and provide advice on event logistics and budget management.
- Provide options for venue, vendor proposal analysis, budget management and solicit sponsorship for activities.

- Design and develop the USCRTF 2015 webpage and registration form, including editing of the page and follow up with participant's daily registration for events. (http://uscrtfm2015.weebly.com)
- Weekly conference meetings with the Watershed Workshop and USCRTFM planning committee as well as follow up with daily emails and phone calls from representatives of the planning committee, vendors and other participants.
- Meetings and site inspections with El Conquistador and its sales staff (Beatriz Palerm and Betzaida Vélez) regarding negotiations for Room Block, rates and concessions for guests; rates and pricing on meeting rooms, food and beverages for meetings (coffee breaks and lunches), BEOs, AV equipment and meeting room set up and design and contracts based on provided USCRTFM budget, PO and meeting's needs and purpose.
- Planning of nightly events, including logistics, entertainment, set up, menus, agenda and transportation (AIC Dinner, Reception and VIP Dinner)
- Sponsorships (negotiation, communications, proposal and follow up).

III. Field trips and Site Visits

TNC hosted the following 2 field trips to Coral Priority Regions for high level US Federal and local government officials:

- Snorkeling and site visits to Culebra This trip included visits to sites that include
 watershed restoration techniques utilized to abate land-based sources of pollution
 (LBSP), coral nurseries to grow coral fragments for restoration, and areas of coral
 propagation to expand coral habitat area.
- Diving in Arrecifes la Coordillera of the Northeast Reserve This trip included
 alternated site visits to the Natural Reserve and the Northeast Ecological Corridor
 Natural Reserve. Cordillera Nature Reserve consists of a chain system formed by cays,
 islands and reefs. The Northeast Ecological Corridor is a Natural Reserve that protects
 over 45 miles of coastal ecosystems that include beaches of national importance for
 the nesting of marine tortoises. Its marine extension covers important ecosystems of
 seagrass and reefs that serve as habitat for species of ecological and commercial
 interests.
